GIS In the Rockies 2010

The 23rd annual GIS in the Rockies Conference, "Endless Opportunities for the Next Decade," is set to take place September 14-17, 2010 at The Ranch in Loveland, Colorado.

ASPRS will host two presentation tracks during the conference:

1) "Imagery and Elevation Data: Foundations for GIS and Modeling"

The accuracy of a GIS or a geospatial model is only as good as the data or information it is based upon. A critical source for the majority of GIS and modeling data is derived from imagery and digital elevation data. As a foundation for GIS and modeling, it is crucial to understand how imagery and elevation data is collected and processed to derive the many types of data and information used in geospatial systems. This broad topic covers primary imagery and elevation data acquisition, preprocessing and processing, data and information extraction techniques, different applications, accuracy, QA/QC, data standards and formats, and other considerations when utilizing imagery and elevation data in GIS and modeling systems.

2) "The Role of Imagery and GIS in Decision Support Systems"

How is imagery and GIS used to help managers make more informed decisions? In many cases, spatial decisions have far-reaching effects regarding property rights, land

use, zoning, etc., or decisions need to be made quickly, such as in emergency management events. Imagery and GIS are critical in helping to collect, filter and assess large amounts of disparate data to aid in all phases of planning, situation awareness, and decision support. Presentations for this topic address how imagery and GIS are used in all elements of a decision support system, from planning and preparedness, to situation awareness and response, monitoring, mitigation and recovery.

ASPRS National Director Report - The Washington Beat

In my capacity as National Director I have been enlightened by many National ASPRS-driven initiatives. For me, one of particular surprise and interest is the formation of the Coalition of Geospatial Organizations (COGO) in August 2008. We, as residents of the geospatial community, are all affected by the actions of COGO, so I thought it important to convey the underpinnings of the organization. The items below are extracted from

Rocky Mountain Compiler

Rules of Operation and Procedure, "COFPAES Model" Organization of Stakeholders in the Geospatial Community (approved August 4, 2008). This Coalition is a force to be reckoned with, and can potentially have a positive influence on the Nation's Geospatial Policies. Organizations participating in COGO who actively engage in knocking on the doors of Congress include NSGIC, MAPPS, NACo and WGA. The real test will come when these organizations are pressed to act in a collaborative manner. One might consider COGO as the ultimate body to foster industry, education and government "Geo-organizational Collaboration." However, let us also acknowledge that many of these organizations can, and have, behaved with parochial interests first and foremost. Opinions on the best path to move forward Nationally vary greatly on issues of credentials, certifications, and the inclusive or exclusive nature of the geospatial profession. As a result, all of these organizations should be monitored and, at times, held in check by our collective memberships, regional entities and elected officers. So the question remains ... Who watches those individuals designated to craft our future and define our legacy?

PURPOSE: The general purpose of COGO shall be to provide a forum for organizations concerned with national geospatial issues that will 1) improve communications among the member organizations

(and others), 2) provide educational information on relevant issues for their respective memberships, 3) align and strengthen their respective policy agendas, and 4) facilitate development of strategies to address national issues.

The objectives in carrying out its general purpose shall be: 1. Developing programs of coordination and mutual action by member organizations that positively affect the interests of the membership from each of the Member and Advisory organizations. Subjects may include, without limitation, legislation, agency policies and regulations, publications (including a website), conferences and seminars. 2. Providing a framework maintaining awareness and coordinating policy positions of the organizations comprising COGO, as such policy positions relate to issues at the federal, state and local levels.

AUTHORITY: Adoption of Policy Positions
COGO shall undertake legal or advocacy action only through unanimous agreement of all of the Delegates in accordance with its purposes on behalf of the Member Organizations. Each Member Organization or Advisory Organization reserves the right to express separate views or take independent action when it is not in agreement with a proposed course of action presented for consideration by COGO, except that no Member Organization or Advisory Organization shall take a contrary public position or bring suit or commence legal action (external or internal) without first submitting notice of such intent to COGO for consultation prior to the initiation of such action. Notice of such intent to take a position or to commence legal action is to be given as early as practically feasible so that, if time permits, COGO may provide counsel on the matter and may determine whether or not COGO concurs in such action.

Your comments on COGO are welcome.
